11. Item 9 (Other Events)

We disclose that at the meeting of the Board of Directors of PLDT Inc. (respectively, the "Board" and the "Company") held on March 4, 2021:

- 1. The Board approved or confirmed the following items in connection with the Annual Meeting of Stockholders for 2021:
 - a. The Annual Meeting of Stockholders of the Company will be held on June 8, 2021 at 3:00 o'clock p.m. via remote communication (the "Annual Meeting"). Per the By-Laws of the Company, the annual meeting of stockholders shall be held on the second Tuesday in June.
 - b. The record date for the determination of stockholders entitled to notice of and to vote at the Annual Meeting is April 12, 2021. The stock and transfer books of the Company will not be closed.
 - c. The last day for filing proxies in connection with the Annual Meeting is on June 1, 2021.
 - d. The validation of proxies in connection with the Annual Meeting will be done on June 3, 2021.
 - e. In accordance with the Company's By-Laws, the nominations for election of directors/independent directors at the Annual Meeting shall be submitted to the Board of Directors through the President or Corporate Secretary at the Company's principal place of business at least sixty (60) working days before the meeting or by March 11, 2021.

The notice, agenda and other materials required to be distributed to the stockholders in connection with the Annual Meeting will be submitted to the Securities and Exchange Commission and the Philippine Stock Exchange in accordance with the applicable rules.

- 2. The Board declared the following cash dividends out of the unaudited unrestricted retained earnings of the Company as at December 31, 2020, which are sufficient to cover the total amount of dividends declared:
 - a. Final regular dividend of ₱40.00 per outstanding share of the Company's Common Stock, payable on April 6, 2021 to the holders of record on March 18, 2021.
 - b. ₱2,437,500.00 on all of the outstanding shares of the Company's Voting Preferred Stock for the quarter ending April 15, 2021, payable on April 15, 2021, to the holder of record on March 24, 2021.

Pursuant to the requirements of the Securities Regulation Code, the Company has duly caused this Report to be signed on its behalf by the undersigned hereunto duly authorized.
