11. Item 4 (Resignation of Director)

We disclose that at the meeting of the Board of Directors of Philippine Long Distance Telephone Company (respectively, the "Board" and the "Company") held on September 25, 2012, the Board accepted the resignation of Rev. Fr. Bienvenido F. Nebres as an independent director, Chairman of the Audit Committee, and member of the Executive Compensation and Governance and Nomination Committees, effective immediately. The Board expressed their sincerest gratitude to Rev. Fr. Nebres for his long and invaluable service to the Board, its Committees and the Company.

Rev. Fr. Nebres has no disagreement with the Board and there are no matters relating to his resignation that need to be brought to the attention of the shareholders of the Company. His resignation is not expected to have any significant impact on the Company's current or future operations, financial position or results of operation.

The Board intends to elect another independent director to fill the Board vacancy after the Governance and Nomination Committee shall have completed the independent director nominee selection and screening process.
