11. Item 4 (Resignation, Removal or Election of Registrant's Directors or Officers) Item 9 (Other Events)

At the meeting of the Board of Directors of PLDT Inc. (respectively, the "Board" and the "Company") held on December 3, 2020:

1. The Board approved the retirement of Ms. June Cheryl A. Cabal-Revilla from her roles as Senior Vice President/PLDT Group Controller and Chief Sustainability Officer effective December 31, 2020. Ms. Cabal-Revilla is also retiring from her role as Chief Financial Officer of Smart Communications, Inc. (SMART) effective December 31, 2020. PLDT Group Chief Financial Officer and Chief Risk Management Officer, Ms. Anabelle L. Chua, will serve concurrently as Chief Financial Officer of SMART, effective January 1, 2021.

The aforementioned event is not expected to have any significant impact on the Company's current or future operations, financial position or results of operations.

- 2. The Board approved the extension of the effective date of retirement from employment of Atty. Marilyn A. Victorio-Aquino, Senior Vice President, Chief Legal Counsel and Head of Corporate Affairs and Legal Services from January 1, 2021 to December 31, 2022;
- 3. The Board declared a cash dividend of P2,437,500.00 on all of the outstanding shares of Voting Preferred Stock of the Company for the quarter ending January 15, 2021, payable on January 15, 2021, to the holder of record on December 18, 2020.

The cash dividend was declared out of the unaudited unrestricted retained earnings of the Company as at June 30, 2020, which are sufficient to cover the total amount of dividend declared.
