

Further to our disclosures dated 8 November and 26 November 2018 filed with the Exchange, PLDT on 3 December 2018 completed the closing of its investment in Multisys Technologies Corporation ("Multisys"), a Philippine software development and IT solutions provider. Upon the approval by the Philippine SEC of the capital increase of Multisys, PLDT will own a total equity stake of 45.73% in Multisys through a combination of new and existing shares of Multisys.
