- a. Regular dividend of ₱69.00 per outstanding share of the Company's Common Stock, payable on September 26, 2014 to the holders of record on August 28, 2014; and
- b. ₱12,420,000.00 on all of the outstanding shares of the Company's Series IV Cumulative Non-Convertible Redeemable Preferred Stock, for the quarter ending September 15, 2014, payable on September 15, 2014 to the holder of record on August 20, 2014.
