- 1. The Board noted and confirmed the appointment of Sycip Gorres Velayo & Co. as the Company's external auditors to audit the financial statements of the Company for the year 2016 by the Audit Committee in its meeting held on May 2, 2016;
- 2. The Board declared the following cash dividends out of the audited unrestricted retained earnings of the Company as at December 31, 2015, which are sufficient to cover the total amount of dividends declared:
 - a. P12,420,000.00 on all of the outstanding shares of the Company's Series IV Cumulative Non-Convertible Redeemable Preferred Stock, for the quarter ending June 15, 2016, payable on June 15, 2016 to the holder of record on May 24, 2016.
 - b. ₱1.00 per outstanding share of the Company's Series JJ 10% Cumulative Convertible Preferred Stock, for the annual period ending May 31, 2016, payable on June 30, 2016 to the holder of record on June 2, 2016.
